## WHAT DOES D&D Motors S, Inc. DO WITH YOUR PERSONAL INFORMATION?

### Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

### What?

The types of personal information we collect and share depends upon the product and/or service you have with us. This information can include:

Social Security number and income  
Credit History and Credit Scores  
Checking Account info and employment information

### How?

All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons D&D Motors S, Inc. chooses to share and whether you can limit this sharing.

## What We Do...

### **How does D&D Motors S, Inc. protect my personal information?**

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

### **How does D&D Motors S, Inc. collect my personal information?**

We collect your personal information, for example, when you:

- apply for a loan or use your credit card or debit card
- Give us your paystubs or apply for financing
- Give us your income information

We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.

### **Why can't I limit ALL sharing?**

Federal law gives you the right to limit only:

- sharing for affiliates' everyday business purposes, information about you credit-worthiness.
- affiliates from using your information to market to you
- Sharing for non-affiliates to market to you

State laws and individual companies may give you additional rights to limit sharing.

### **What happens when I limit sharing for an account I hold jointly with someone else?**

We do not share.

## Definitions

**Affiliates** - Companies related by common ownership or control. They can be financial or non-financial companies.

- D&D Motors S, Inc. has NO affiliates.

**Non-Affiliates** - Companies not related by common ownership or control. They can be financial and/or non-financial companies.

- D&D Motors S, Inc. does NOT share with non-affiliates, so they can't market to you.

**Joint Marketing** - A formal agreement between non-affiliated financial companies that together market financial products or services to you.

- D&D Motors S, Inc. does NOT jointly market.
